Annual Meeting

We had about 50 folks join us for the annual meeting at Peninsula School on November 7th. Due to the auditorium being unavailable, we set up chairs in the gymnasium.

Remona Murray gave her Treasurer report and thanked our MODA Board Members Joel Wilhite (President), Holly Still (VP), Rich Collyer (Editor), Marge Draper (Welcoming Committee), Terry Tsu (M-A Liaison), James Dowley (MP City Liaison), Dave Jevans (Webmaster) and Jennifer Dignum for their hard work and dedication. It is through their input that our neighborhood newsletter, picnic and annual meeting take place.

The two main topics covered were the status of the Coleman Avenue petition and the changes and updates at Menlo-Atherton High School (MAHS) due to Measure H.

I invited Carla Dewar to make a presentation regarding her petition for a bicycle/pedestrian pathway on Coleman Ave. to the audience. I also presented some follow up material that we received from the county to bring the meeting attendees up to speed with what has been discussed to date.

The floor was then opened to the general comments of the attendees and could have gone on beyond the hour that we allowed for the subject. The main action item that came up was the need to have a meeting with all 20 property owners on Coleman Avenue who will be impacted by the plan. The MODA board is planning a meeting to be held in March.

We also covered some issues that were brought to my attention during the last year regarding MAHS. After collecting all the comments forwarded to me over e-mail, I took the list over to the school and met with the administrative staff. After having met with the school I relayed some of their positions and actions back to the folks at the meeting.

We asked for and got a neighbor from the meeting, Charles Riley, to help liaison with MAHS. Charles and I will be going back to visit with the new MAHS principal, Mr. Estrada, to find out what actions are being taken to correct the issues our neighborhood has with MAHS. We hope to determine if there are ways we can help them resolve our issues.

Three members of the MODA Board members terms had expired. So we said goodbye to Terry, James and Jennifer. The opening were filled by Charles Riley, Celine Sanie, and Mary Sapountzis.

There are over 36 new families with small children that have moved into the neighborhood since 2000.

When walking in the evening wearing light or reflective clothing and carrying a flashlight allows drivers to see you better.

Ordinance Section

7.28.030 Parking of Commercial Vehicles.

Recently there was a discussion about a tree company parking their truck and chipper overnight along the streets of the Menlo Oaks District. The discussion took place on the MODA Bulletin Board. During the discussion it was determined that there was a county ordinance against the parking of commercial trucks along our street for more than one (1) hour. There is a fine of \$30 for any vehicles that are found breaking this ordinance. I have included the text of the ordinance below, in case you are concerned about what is legal and not legal.

+++++

No person, firm or corporation, nor any agent or employee thereof, shall stop, leave standing, or park for the period of more than one (1) hour any commercial vehicle, whether attended or unattended, upon a street, road, highway or other thoroughfare, or place of whatever nature, publicly maintained and open to the use of the public for the purpose of vehicular travel, located in any residential zone in the unincorporated area of said County, except when such vehicle is in actual use for the transaction of any lawful business in said zone or is temporarily disabled.
